A direct phone line to the ECR department is available, if needed, when dropping off the request <u>OR</u> Mail this completed request form to Electronic Court Reporting at the Lee County courthouse address listed above along with your payment.

• Personal check or money order must be made **payable to "State of Florida"** in the amount of **\$25 for each proceeding per date requested.** Payment is required before your request can be processed.

• When the recording is ready, you will be notified of such at the contact information you provide

below. Requests will be filled within 7-10 business days from receipt of full payment. ANY REQUEST NOT PICKED UP after processing and notification WILL BE DISCARDED AFTER 30 DAYS.
