

Act); Florida Statute §744.369 (Guardianship Reports); and Fla. Fam. L. R. P. 12.491 (Child Support
Enforcement Hearing Officer) to perform duties in accordance with applicable Florida Statutes and federal
law, court rules, and the terms and conditions of the Title IV-D Child Support Enforcement Hearing Officer
Requirements.

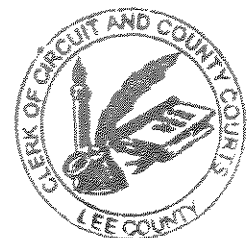
