IN RE: COSTS IN COUNTY COURT

ADMINISTRATIVE ORDER NO. 6.1

Pursuant to the authorities cited below and the inherent authority of the court as provided in Fla. R. Jud. Admin. 2.215 and Florida Statute §43.26, the following schedule of fees is hereby adopted for the County Court.

# I. MISDEMEANOR, AND CRIMINAL TRAFFIC

# A. Mandatory Court Costs

- 1. The County Court <u>shall</u> impose the following costs in <u>all</u> misdemeanor, criminal traffic and ordinance violations punishable as misdemeanor <u>cases</u> where the defendant pleads guilty or nolo contendere or is otherwise convicted of a misdemeanor:

  - \$ 65 County Court Costs

# B. Amounts After Hearing

- 1. If after a hearing, the official determines that an infraction was committed, the official may impose a civil penalty not to exceed \$500, except in cases involving unlawful speed in a school zone, involving unlawful speed in a construction zone, or involving a death, the civil penalty may not exceed \$1000.

All fines, costs, penalties or other assessments against any defendant in accordance with this administrative order shall be collected by the Clerk of the Court and distributed in accordance with the applicable provisions of Florida law and the Distribution Schedule of Court-Related Filing Fees, Service Charges, Costs, and Fines published by the Florida Association of Court Clerks, Inc..

The monetary fines and costs imposed by the court shall be deemed to include only statutory and constitutional costs and fees. Any cost found to be unconstitutional by any court of superior jurisdiction shall be considered as part of the fine imposed and shall be distributed as otherwise provided by law.

To the extent that any provision of this Administrative Order may conflict with any rule, statute or law, the rule, statute or law shall prevail. More specifically, to the extent that the Legislature may make subsequent amendments that increase, decrease, add or delete any cost, fines or fees, those legislative amendments shall prevail.
