WHEREAS, the establishment of domestic violence divisions within the Twentieth

Judicial Circuit was approved by the Supreme Court of the State of Florida on October 26, 1994,

under Local Rule IX; and

WHEREAS, a Domestic Violence Court for Collier County was initially established by administrative order entered October 31, 1996, but has since ceased to operate; and

WHEREAS, the Florida Supreme Court has recognized the extreme importance of having domestic violence issues addressed in an expeditious, efficient, and deliberative manner, <u>In re</u>

Report of the Commission on Family Courts, 646 So. 2d 178 (Fla. 1994);

NOW THEREFORE, pursuant to this Court's inherent authority to administer and regulate the courts of the Twentieth Judicial Circuit, as well as the authority prescribed by Fla. R. Jud. Admin. 2.215 and Florida Statute §43.26, the Court hereby reestablishes the Domestic Violence subdivision of the county misdemeanor court for Collier County, Florida.¹

It is ORDERED that county court cases in Collier County involving charges of assault under Fla. Stat. §784.011(2) or battery under Fla. Stat. §784.03(1)(b) that are based on allegations of domestic violence as identified on either the booking sheet or in the information filed by the State Attorney, and county court cases involving charges of violation of an injunction for protection against domestic violence under Fla. Stat. §741.31, violation of pretrial release under Fla. Stat. §741.29(6), violation of any of the prohibitions regarding the possession of firearms and ammunition under Fla. Stat. §790.233, and violation of an injunction for

protection against repeat violence, sexual violence, dating violence, or a foreign protection order under Fla. Stat. §784.047, shall be assigned to the Misdemeanor Domestic Violence Subdivision.²

The previous Order Establishing Domestic Violence Court for Collier County entered October 31, 1996, was vacated by original Administrative Order 6.8 entered October 1, 2009.

Effective May 1, 2010, the County Administrative Judge for Collier County shall make all judicial assignments to the Misdemeanor Domestic Violence Subdivision, and any judicial assignment orders regarding this subdivision entered prior to May 1, 2010 shall thereafter be deemed vacated.

To the extent that this order may conflict with any rule, statute or law, the rule, statute or law shall prevail.
