# ORDER REQUIRING ISSUANCE OF STANDING ORDERS IN DOMESTIC RELATIONS CASES IN LEE COUNTY

Pursuant to Administrative Order 2.12 and the responsibilities delegated by the Chief Judge to the Administrative Family Law Judge of the Family Law Division, and in an effort to more expeditiously process domestic relations cases filed in the circuit court of the Twentieth Judicial Circuit in and for Lee County, Florida, the Clerk of the Court is hereby authorized and directed to issue and serve the following documents as set forth below on all parties to all domestic relations matters filed in Lee County:

#### 1. STANDING TEMPORARY DOMESTIC RELATIONS ORDER

This order shall be issued and served upon all parties to every dissolution of marriage proceeding where minor children are involved and no marital settlement agreement has been attached to or referenced in the Petition.

#### 2. STANDING ORDER FOR PARENTAL-EDUCATION CLASSES

This order shall be issued and served upon all parties to all dissolution of marriage cases where minor children are involved.

## 3. STANDING TEMPORARY DOMESTIC RELATIONS ORDER (NO CHILDREN INVOLVED)

This order shall be issued and served upon all parties to dissolution of marriage proceedings in which no minor children are involved and no marital settlement agreement has been attached to or referenced in the Petition.

### 4. NOTICE TO ALL PARTIES IN THE FAMILY COURTS

This "notice" regarding the policies of the Family Law Division of the Lee County Circuit Court shall be issued and served upon all parties to all dissolution of marriage proceedings without exception.

The Clerk of Court is hereby authorized and directed to issue and serve these orders, where applicable, on the Petitioner upon filing of the action and on the Respondent by attaching a copy to the summons to be served on Respondent. This directive shall not apply to those proceedings governed by the simplified dissolution procedures prescribed by Rule 1.611(c), Florida Rules of Civil Procedure.
